

Canyon Club - USTA League Rules

Team Captain Policies

- Only members of Canyon Club are allowed to reserve courts. Members may not reserve courts for USTA league matches or practices unless the team is playing out of, and captained by members, of the club Canyon Club
- A team may ask up to three guest players to join their team for only one season a year
- A guest pass will be noted to the players name once he/she has paid the season league fee
- Please submit forms back to the Tennis Director upon completion, forms due one week prior to league start date
- If you should add players during season, simply notify the Tennis Director of any updates to the roster
- Other
 - We encourage captains, and players, to please keep the tennis department informed of team/player accomplishments that happen throughout the season. We have some amazing teams and members and would love to share the triumphs with our tennis members
 - Examples
 - Team makes it to sectionals/nationals
 - 'Comeback Story'. Down luv 40, 0-5 in the second set only to win it 12-10 in a third set tie breaker
 - Victory against an undefeated opposing team
 - Undefeated season, etc.

Guest Player Rules

- Captains may ask up to 3 friends/stronger players to join/assist their teams during a league season
- Guest players will be limited to playing on only one team per year
- Guest players must pay the season fee of \$75 before the seasons start date
 - If they are added mid-season, it is up to the captain to update the roster. The full amount of \$75 will stand regardless of when the player joins
- What guest players are invited to do
 - Players may be invited to join one team practice a week, during season, with only their teams
 - Players can attend 1 or more paid team session(s), on top of the team practice, with the Canyon Club Pro Staff
- What guest players will not be allowed to do
 - Players are not allowed to play on more than one team during a season
 - Ex) rated 4.0 and play on a 4.0 as well as a 4.5 team
 - Players are not allowed to use the swimming pools, pickleball courts, or golf course
 - Players will not be allowed to stay and use the tennis courts after any match, practice, and paid session
